B. Information Collected Automatically

- **Device & Usage Data:** IP address, browser type, operating system, referring URLs, pages viewed, and access times collected via cookies and tracking technologies.

2. How We Use Your Information

We use the personal information we collect solely for business related purposes, including:

- Processing transactions through our 3rd party credit card processing company and sending you payment confirmations without retaining any of your data.
 - Operating our SMS messaging program (e.g., appointment reminders, tax-related questions and invoice inquiries).

3. Short Message Service (SMS) & Mobile Messaging Terms

We do not sell your personal data. We may share non-SMS personal information only under the following limited circumstances:

- **Service Providers:** Vendors and contractors who perform services on our behalf (e.g. Payment processing, email delivery) under strict confidentiality agreements.
 - **Legal Requirements:** When required by law, subpoena, or government order, or to protect our legal rights and safety.
